- I am solely responsible for any injury, loss or damage that I might sustain while participating; and
- I release the Organization from liability for any and all claims, demands, actions and costs that might arise out of my participating, even through such risks, injuries, loss, damage, claims, demands, actions or costs may have been caused by the negligence of the Organization.
